## Suggested Amendments to the Bylaws of the American Chemical Society, Dayton Section

- All incidences of "Chairman" **to be changed to** "Chair" or "Chairperson." All incidences of "Chairman-Elect" **to be changed to** "Chair-Elect." All incidences of "Immediate Past Chairman" **to be changed to** "Immediate Past Chair."
- All incidences of "he" to be changed to "they." All incidences of "his" to be changed to "their." All incidences of "him" to be changed to "them."
- **Bylaw 1. Section 5.** "Masculine forms shall be used in these bylaws for the sake of brevity." **to be deleted**.
- **Bylaw 4. Section 5.** "There shall be the following standing committees: Program, Professional Practices, Membership, Public Relations, Awards, Education, and Long Range Planning." **to be changed to:** "There shall be the following standing committees: Archives, Awards, Bulletin, Education, Industrial Relations, Long Range Planning, Membership, Professional Practices, Program, Public Relations, Women Chemists and Younger Chemists."
- **Bylaw 4. Section 8.** "The Chairman-Elect shall serve as chairman of the Program Committee." **to be changed to:** "The Immediate Past Chair shall serve as chairperson of the Program Committee. The other members of this committee shall be the Chair and Chair-Elect."
- **Bylaw 5. Section 1.A.** "The Chairman-Elect, the Secretary, the Treasurer and the Professional Practices Chairman shall serve a one-year term of office beginning on January first following their election." **to be changed to:** "The Chair-Elect shall serve in sequence one year as Chair-Elect, one as Chair, and one year as Immediate Past Chair, with each term of office beginning on January first."
- **Bylaw 5. Section 1.B.** "The Chairman-Elect shall serve in sequence one year as Chairman-Elect, one as Chairman, and one year as Immediate Past Chairman, with each term of office beginning on January first." **to be changed to:** "The Secretary and Treasurer shall serve a two-year term of office beginning on January first following their election. The election of these two offices will be held on alternate years from each other; the Secretary in odd numbered years and the Treasurer in even numbered years."
- **Bylaw 5. Section 1.E.** "A MEMBER serving in any elective position may be elected to any office, provided his present term of office will have expired before his assumption of the new office, or provided he resigns his office on consenting to become a candidate for the new office." **to be changed to:** "A MEMBER serving in any elective position may be elected to any office, provided their present term of office will have expired before their assumption of the new office, or provided they resign from office on consenting to become a candidate for the new office."

- **Bylaw 6. Section 3.A.** "The Chairman-Elect, Secretary, Treasurer, Councilors and Alternate Councilors and Professional Practices Chairman shall be elected by secret ballot." **to be changed to:** "The Chair-Elect, Secretary, Treasurer, Councilors and Alternate Councilors shall be elected by secret ballot."
- **Bylaw 8. Section 5.** "The Executive Committee shall meet as often as necessary to conduct its business. Business of the Executive Committee which is of an urgent nature may be conducted by telephone." **to be changed to:** "The Executive Committee shall meet as often as necessary to conduct its business. Business of the Executive Committee which is of an urgent nature may be conducted by telephone or e-mail."
- **Bylaw 10.** "...The Board of Directors shall be charged with preserving and increasing the corpus of the Fund. At the discretion of the Board, income in excess of that needed to adequately fund the Patterson-Crane Award may be used in funding the Patterson College Awards. The Patterson College Award will consist of grants-in-aid made to outstanding Junior year college chemistry majors at colleges within the Dayton Section area." **to be changed to:** "...The Board of Directors shall be charged with preserving and increasing the corpus of the Fund. At the discretion of the Board, income in excess of that needed to adequately fund the Patterson-Crane Award may be used in funding the Patterson College and High School Awards. The former will consist of grants-in-aid made to outstanding Junior year college chemistry majors at colleges in the Dayton Section area. The latter will consist of three cash awards to the top performers in the annual Patterson High School Awards Competition and recognition plaques to the top performers from each participating school."

Applications consist of a letter of intent, a résumé, and two letters of reference. Candidates should contact ACS prior to submitting an application to determine the type of information needed in tletter of intent. Arrangements should be made to send the letters of reference directly to ACS.

### Orphan Chemical **Exchange Program**

The Orphan Chemical Exchange Program was designed to facilitate the exchange of usable, but unwanted, laboratory chemicals among industrial companies, educational institutions and research facilities, thereby decreasing the amount of chemicals that become wastes. Donor institutions benefit by reducing their inventory of unwanted chemicals and waste management costs. Parties receiving the orphan chemicals will reduce their chemical acquisition costs.

This program was initiated by members of the Health, Safety and Environmental Committee of the Cleveland Association of Research Directors and Cleveland State University.

Members of the program who want to donate chemicals provide information about chemicals using the program's web site (http://www.cestp. csuohio.edu/orphan/ orphan.html). Members interested in obtaining chemicals from donor institutions may submit their order through a specific web page. An email message is sent to the donor company indicating that a specific member is interested in their chemicals. The donor company will then contact the potential recipient member. This process protects the anonymity of the donor company. If both parties agree to the transaction, the recipient will then make arrangements for delivery using a commercial carrier.

The website contains information about the program, its rules and regulations, a membership application form and the list of chemicals presently available.

There is no membership fee.


### The 1998 National Chemistry Week Poster Contest "A World of Color"
